SPECIAL TERMS CONDITION.

- 1 The NIT has been called as per vide letter No.PHEWS/30/2023-PHEWS Br-PHEWS Dtd. 13th March 2023
- 2 It is compulsory for the Bidders to visit, examine and familiarize themselves with the work sites including source of principal materials like sand, aggregates etc. on his/ her own cost, before submitting the bid.
- 3 The rates should be quoted both in **figure and words** in the schedule of quantities and all the papers including NIT should be put in sealed envelope.
- 4 The firm must have sound financial background to complete the project even at the eventuality of unavoidable delay in payment. No interest will be paid for delay in payment and further no escalation of cost whatsoever will be entertained by the department.
- 5 The firm must have successfully executed, in Central/ State Government/ PSU, three similar works, each of value of 30% of the estimate cost put to tender or two similar works each of value, not less than 40% of the estimated cost or one similar work 50% of estimated cost (rounded off to nearest Ten lakhs in the last 5 (five) years. For the purpose of this clause. The applicants not supported with requisite **experience certificate shall not be entertained.**
- 6 **Any kind of tempering/ overwriting of schedule of quantities by the bidders will cause his bid to be disqualified and rejected.**
- 7 The competent authority on behalf of the Governor of Arunachal Pradesh does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected. Decision of the board on selection of winning bidder shall be the final and binding. Lowest financial bidding shall not be the mandatory condition for selection of winning bidders. The undersigned reserves the right to reject the lowest tender if the quoted rates are found abnormally unjustified.
- 8 The bidder must furnish up to date account/ return of GST, PAN Number, latest Income Tax certificate and related papers with the tender.
- 9 The firm must submit proof of having adequate manpower/ technical expertise and necessary equipments to handle such projects.
- 10 The firm/ contractor must submit an original copy of latest Bank solvency and Bank guarantee certificate from any Nationalized Bank in support of his financial soundness along with the tender paper.
- 11 **The firm should be able to complete the project within 31st July' 2023 from the date of agreement of work.**
- 12 The firm should submit No Objection Certificate/ No Dues Certificate from MD, Apex Bank, Arunachal Pradesh along with the tender documents.
- 13 Latest report of three years duly certificate/ audited by the Chartered Accountant should be submitted, but in case of **new registered firm it will be exempted.**
- 14 **The firm should not form any joint venture or enter into association with any other agency for execution.**

SPECIAL TERMS CONDITION.

- 15 **The successful bidder shall provide to the employer a total Performance guarantee @ 5% (Five percent) of the tendered amount, out of which 2.5% shall have to be paid at the time of signing of agreement in the form of FDR/DCR/DD issued by Nationalized bank and the balance 2.5% shall be deducted from the contractor's bill for security amount, if not submitted.**
- 16 **No advance payment in the form of mobilization charges will be made to the successful tenderer. Payment will be made as per the progress of works and availability of fund.**
- 17 **Black listed firm and Construction Company against whom black listing contemplated need not apply.**
- 18 **The mineral & mining royalty of the Mineral product such as sand, shingles, and stone aggregates shall be deducted from the tender bill. Labour Cess, GST will be deducted, where ever applicable from the tender bill.**
- 19 **It shall be sole responsibility of the selected firm to meet up any local dispute arising in regards to land, water source etc. during execution.**
- 20 Each bidder must produce an affidavit that the information furnished with the bid documents is correct in all respects.
- 21 **The bidder must submit the working design and drawings of all civil structures along with the technical bid, falling which, has bid will be disqualified and rejected.**
- 22 The bidder must furnish Character certificate from local administration/ Police station, where work is executed.
- 23 **Any contractor who has three (3) or more incompletd ongoing commitments** (Projects to execute/ Contract at hand) is not permitted to participate in this bidding. A bidder will invariably submit an affidavit sworn before a competent magistrate to the effect that he does not have three (3) or more uncompleted ongoing commitments at the time of bidding. Any bid which does not fulfill this condition will summarily be rejected. In the event of submission of false information, which may be detected by the Department after award of works, the tender shall be cancelled immediately & the contractor shall be barred from further participation in any tender(s) of the Department.

TERMS & CONDITION.

- 1 The Tender paper can be purchased from the office of the undersigned on any working day except on Sunday and public holidays on payment of Rs. 1500.00 (Rupees One thousand five hundred) (non-refundable) in cash or in shape of DD in favour of the Executive Engineer, PHE & WS Division, Palin, payable at state Bank of India, Palin Branch.
- 2 The tender documents shall be sold/issued to the eligible contractors/firms subject to produce proof of Permanent Resident Certificate (PRC) and contractors/Firms registered Certificate, AS PER ARUNACHAL PRADESH DISTRICT BASED ENTERPRENEURS AND PROFESSIONALS (INCENTIVES, DEVELOPMENT AND PROMOTIONAL) ACT, 2015/ 2020.
- 3 The tender shall be submitted in two bids i.e. Technical Bid and Financial Bid and each of the bids shall be placed and sealed properly in two separate covers for each of the above works and should be delivered/submitted to the Executive Engineer, PHE & WS Division, Palin & should be dropped into respective tender box for Palin/Yangte & Chambang/Gangte Blocks. The authority inviting tender, will not be held responsible for the delay, if any, in the delivery of the documents or non-receipt of the same in time.
- 4 The Technical Bids shall be first opened specified as indicated in coloumn Number (11) only on at the office of the Executive Engineer, PHE & WS Division, Palin in presence of intending tenderers or their authorized representatives and will be evaluated to assess the technical viability, capability, work experience and then only the financial bid of the qualified tenderer shall be opened after the approval of technical bid by the competent authority. The technical & financial bids will be evaluated by standing screening committee whose decision shall be final.
- 5 The bids must be accompanied by earnest money of amount specified as indicated in column No. 7 only against each tender package in the form of FDR/DD/DCR of any scheduled bank guaranteed by the Reserve Bank of India issued in favour of the Executive Engineer, PHE & WS Division, Palin in a separate envelope mentioned as "Earnest Money" on it along with the tender. No other kind of deposit as earnest money will be accepted. The tender without earnest money shall be summarily rejected.
- 6 On the event of non-opening of tender on the specified date & time, the undersigned shall notify new date and time in the office Notice board.
- 7 The undersigned reserves the right to reject any or all tender without assigning any reasons.
- 8 All other terms and conditions shall remain same and may be seen in the Tender Documents/ Bidding documents.
