

2. The tender shall be submitted in two bids i.e. Technical Bid and Financial Bid and each of the bids shall be placed and sealed properly in two separate covers for each of the above works and should be delivered/submitted to the Executive Engineer, PHE & WS Division, Likabali on or before **08th December'2021** Up to 10.30 am. The authority inviting tender, will not be held responsible for the delay, if any, in the delivery of the documents or non-receipt of the same in time.
3. The Technical Bids shall be first opened on **8th December'2021** at 12.30 Pm at the office of the Executive Engineer, PHE & WS Division, Likabali in presence of intending tenderers or their authorized representatives and will be evaluated to assess the technical viability, capability, work experience and then only the financial bid of the qualified tenderer shall be opened after the approval of technical bid by the competent authority. The technical & financial bids will be evaluated by standing screening committee whose decision shall be final.
4. The bids must be accompanied by earnest money of amount specified as indicated in column No. 4 only against each tender package in the form of FDR/DD/DCR of any scheduled bank guaranteed by the Reserve Bank of India issued in favour of the Executive Engineer, PHE & WS Division, Likabali in a separate envelope mentioned as "Earnest Money" on it along with the tender. No other kind of deposit as earnest money will be accepted. The tender without earnest money shall be summarily rejected.
5. On the event of non-opening of tender on the specified date & time, the undersigned shall notify new date and time in the office Notice board.
6. The undersigned reserves the right to reject any or all tender without assigning any reasons.
7. All other terms and conditions shall remain same and may be seen in the Tender Documents/ Bidding documents.
8. Any corrections or additions that may become necessary shall be notified through corrigenda or addenda in due course of time.
9. AS PER ARUNACHAL PRADESH DISTRICT BASED ENTERPRENEURS AND PROFESSIONALS (INCENTIVES, DEVELOPMENT AND PROMOTIONAL) ACT, 2020, & CPWD WORKS MANUAL 2014 ONLY CLASS-IV, V, VA REGISTERED CONTRACTOR SHALL APPLY FROM LIKABALI BLOCK, whichever is eligible in the respective packages.
