The authority inviting tender will not be held responsible for the delay of the documents or non- receipt of the same on time. The Technical Bids shall be opened on **above mentioned date and time** in the office of the Executive Engineer, PHE & WS Division, Aalo and evaluated to assess the technical viability, capability, etc and then only the price bid of the qualified tenders shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bids will be opened on next working day at same time and venue.
- 4 During the time of taking tender papers, application should be submitted along with following documents failing in which no tender paper shall be issued.
  - a) Attested copy of valid Registration/Enlistment paper confirming the eligibility of the firm.
  - b) The bidder will have to submit Permanent Resident Certificate.
