The authority inviting tender will not be held responsible for the delay if any, in the delivery of the document or non-receipt of the same on time. Technical Bids shall be opened on 12/07/2022 at 1030 Hrs onward at office of the Executive Engineer, PHE & WS Division, Pasighat and evaluated to assess the technical viability, etc and then only the price bid of the qualified tenderer shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bids will be opened on next working days at same time and venue.

The standard form of General Condition of Contract will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The intending bidder must read the General Condition of Contract 2014 or its latest edition carefully. He/she should only submit his/her bid if he/she agrees the terms and conditions laid therein.


