1. The bidders are required to submit Tender in two bids i.e **technical bids & Price bids**. Each of bid shall be placed and sealed in proper separate cover and mailed by registered post so as to reach to the undersigned or may be dropped in tender box made available in the office of undersigned on or before stipulated date and time specified above. The authority inviting tender will not be held responsible for the delay, if any, in the delivery of the documents or non- receipt of the same on time.
2. The bidders are required to visit the sites to examine and familiarize themselves with concerned site of works and it's surrounding etc. at their own cost and responsibility and risk before submitting the technical bid. The firm may contact the Assistant Engineer In-Charge of the project for visit to the site of works.
3. The Technical bids shall be opened first and evaluated to assess the technical viability of their proposals and capability of the contractors/ firm and their work experience. Based on such evaluation and after adopting the post qualification procedure, a short list of selected contractors shall be made by the competent authority of PHE & WS Department, Govt. of Arunachal Pradesh. The price bids containing only the schedule of quantities with rates duly filled in of post qualified contractors in the prescribed **Form PWD- 7/8** shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bids will be opened on next working day at the same time and venue.
4. Tender documents can be obtained from the office of the undersigned on any working day in between **1000 hrs to 1600 hrs on payment of Rs. 1,000.00 (Rupees One thousand) Only in Cash/ shape of DD (non- refundable) drawn in favour of the undersigned payable at the State Bank of India at Longding/ Kanubari.**No bidding documents shall be issued to the contractor after the stipulated time limit.
5. Earnest money in the form of DCR/ DD/ FDR of nationalized scheduled banks guaranteed by the Reserve Bank of India in favour of Executive Engineer, PHE & WS Division, Longding must be accompanied with each tender failing which will be summarily rejected.
6. The undersigned reserves the right to reject any or all tenders without assigning any reason.
7. The tender shall be opened by the Assistant Engineer in the **Office of PHE & WS Sub-Division, Longding** as schedule.
8. The Bidders may collect the hard copy of Technical Bids and Price Bids from the **Office of PHE & WS Division, Longding** on or before stipulated date and time specified above.
9. The undersigned reserves the right to extend or cancel the tender and change the venue of opening the tender without assigning any reasons.
10. Any kind of tampering and overwriting of BOQ by the bidders will cause his/ her bid to be disqualified and rejected.
11. The bidders are required to submit the original documents to the office of the Assistant Engineer, Longding on the day of opening of the technical bids.
12. **Bidders must submit the hydraulic design and detailed drawings and specifications of proposed structures for evaluation for economical alternative options.**

ELIGIBILITY CRITERIA:

1. The sale tax registration No./ GST No. and PAN No. must be furnished in bidding document. The documents must be authenticated by competent authority.
2. Those firms who have not completed any ongoing projects in the PHE Department within stipulated time in Arunachal Pradesh will not be eligible to participate in tendering.
3. The willing tenderers must have executed similar type of Drinking Water Project or any other important civil construction work in hilly area not less than 20.00 lakh. The certificate in respect of completion of such projects must be obtained from not below the rank of Executive Engineer of the concerned Department.
4. The firm/ bidder participating in tender must be of appropriate **Class- IV & VA registered contractor**.

5. All register contractors in Class V & VA categories domiciled within the concern Block shall be applied for tender work upto 20.00 lakhs and Class IV & VA categories domiciled with the territorial jurisdiction of Assembly Constituency shall be applied for tender work above Rs. 20.00 lakh to Rs. 50.00 lakh.
6. Class of category and that the registration is must be valid on the date of participation of tender, a copy of which must be submitted to the tendering authority.
7. Contractor shall be allowed to participate in the tender on production of proof of permanent residential certificate (PRC) in support of their claim.
8. As per Govt. of Arunachal Pradesh notification No. SPWD/ W- 66/ 2012, Itanagar, Dtd. 02nd November' 2020. The Arunachal Pradesh district based entrepreneurs and professionals (Incentives, Development and Promotional) Act No. 05 of 2015. All register contractors in class IV, V and III categories domiciled within concern Block and territorial jurisdiction of Assembly Constituency are eligible to participate in tender process.
