The Executive Engineer, PHE & WS Division, Longding on behalf of the Governor of Arunachal Pradesh invites sealed item rate tender from approved and eligible **Class- III/II registered contractor** / firm registered with CPWD/ PWD/ BRO/ NEEPCO/ NHPC/ GREF/ MES for sanction schemes under Budget Estimate (BE) of Longding District, Arunachal Pradesh, which will be opened in presence of the intending tenderers or the authorized representative of the firms.

1. The bidders are required to submit Tender in two bids i.e **Technical bids & Price bids**. Each of bid shall be placed and sealed in proper separate cover and mailed by registered post so as to reach to the undersigned or may be dropped in tender box made available in the office of undersigned on or before stipulated date and time specified above. The authority inviting tender will not be held responsible for the delay, if any, in the delivery of the documents or non- receipt of the same on time.
2. The bidders are required to visit the sites to examine and familiarize themselves with concerned site of works and its surrounding etc. at their own cost and responsibility and risk before submitting the technical bid. The firm may contact the Assistant Engineer In-Charge of the project for visit to the site of works.
3. The Technical bids shall be opened first and evaluated to assess the technical viability of their proposals and capability of the contractors/ firm and their work experience. Based on such evaluation and after adopting the post qualification procedure, a short list of selected contractors shall be made by the competent authority of PHE & WS Department, Govt. of Arunachal Pradesh. The price bids containing only the schedule of quantities with rates duly filled in of post qualified contractors in the prescribed **Form PWD- 7/8** shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bids will be opened on next working day at the same time and venue.
4. Tender documents can be obtained from the office of the undersigned on any working day in between **1000 hrs to 1600 hrs on payment of Rs. 1500.00 (Rupees One thousand five hundred) Only in Cash/ shape of DD (non- refundable) drawn in favour of the undersigned payable at the State Bank of India at Longding.** No bidding documents shall be issued to the contractor after the stipulated time limit.
5. Earnest money in the form of DCR/ DD/ FDR of nationalized scheduled banks guaranteed by the Reserve Bank of India in favour of Executive Engineer, PHE & WS Division, Longding must be accompanied with each tender failing which will be summarily rejected.
6. The undersigned reserves the right to reject any or all tenders without assigning any reason.
7. The tender shall be opened by the Executive Engineer in the **Office of PHE & WS Division, Longding** as schedule.
8. The Bidders may collect the hard copy of Technical Bids and Price Bids from the **Office of PHE & WS Division, Longding** on or before stipulated date and time specified above.
9. The undersigned reserves the right to extend or cancel the tender and change the venue of opening the tender without assigning any reasons.
10. Any kind of tampering and overwriting of BOQ by the bidders will cause his/ her bid to be disqualified and rejected.
11. The bidders are required to submit the original documents to the office of the undersigned on the day of opening of technical bids.
12. **Bidders must submit the structural design, detailed drawings and specifications of proposed structures for evaluation for economical alternative options.**

ELIGIBILITY CRITERIA:

1. The sale tax registration No./ GST No. and PAN No. must be furnished in bidding document. The documents must be authenticated by competent authority.
2. Those firms who have not completed any ongoing projects in the PHE Department within stipulated time in Arunachal Pradesh will not be eligible to participate in tendering.

3. The willing tenderers must have executed similar type of building works or any other important civil construction work in hilly areas: -
 - i. Three similar completed works each costing not less than 40% of the estimated cost put to Tender, or
 - ii. Two similar completed works each costing not less than 60% of the estimated cost put to Tender, or
 - iii. One similar completed work costing not less than 80% of the estimated cost put to tender.

The certificate in respect of completion of such projects must be obtained from not below the rank of Executive Engineer of the concerned Department.

4. Class of category and the registration must be valid on the date of participation of tender. A copy of the same must be submitted to the tendering authority.
5. Contractor shall be allowed to participate in the tender on production of proof of permanent residential certificate (PRC) in support of their claim.
6. As the Arunachal Pradesh District based Entrepreneurs and Professionals (Incentives, Development and Promotional) (Amendment) Act, 2020 (Act No. 7 of 2020), all registered contractors in class-III and II categories domiciled within the territorial jurisdiction of 59th Longding- Pumao Assembly constituency are eligible to participate in the tender.


